[The review area is approximately 170 acres \(ac\) of intermittent forested land, and farmland adjacent to Eighteen Mile Creek Road and WV Route 62 near Buffalo, in Putnam County, West Virginia. The review area primarily includes agriculturally disturbed landscapes](#)

dominated by agricultural fields and intermittent forested habitat. Portions of the site have been modified by current and prior agricultural use, initiated prior to December 23, 1985.

The 400 acre (ac) site contains features that have been evaluated for possible jurisdiction, including NJD VG-1 [325 linear feet (lf)], NJD VG-2 (434 lf), NJD VG-3 (730lf), NJD VG-5 (336 lf), NJD VG-5A (200 lf). The closest jurisdictional stream is Eighteen Mile Creek, a direct tributary to the Kanawha River.

Additionally, NJD OW-2 (0.22 ac), NJD W001 (3.61 ac), NJD W002 (1.3 ac), NJD W003 (0.36 ac), NJD W004 (0.51 ac), NJD W005 (0.21 ac), and NJD W006 (0.28 ac) were evaluated for possible jurisdiction. These aquatic features do not present a hydrological connection to the tributary system.

The approved JD boundary includes non-jurisdictional, isolated reaches of five (5) streams, totaling 2,025 lf, 0.22 ac of open water features, and 4.91 ac of emergent wetland. According to the information provided, these isolated reaches do not present a hydrological connection to the tributary system. As such, NJD VG-1, NJD VG-2, NJD VG-3, NJD VG-5, NJD VG-5A, NJD OW-2, NJD W001, NJD W002, NJD W003, NJD W004, NJD W005, and NJD W006 are not considered jurisdictional features.

A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a

TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
