SECTION II: SUMMARY OF FINDINGS

In LRH Public Notice 94-40, dated 27 July 27 1994, the Tuscarawas River was determined to be a Section 10 (navigable) water of the United States from the mouth at Coshocton, Ohio, to MP 113.3, at Akron, Ohio. Therefore, the Tuscarawas is a TNW.

2. Wetland adjacent to TNW

Summarize rationale supporting conclusion that wetland is “adjacent”:
Wetland 1 is a forested wetland located on the right descending bank of the Tuscarawas River on the southeastern portion of the 174-acre site (approximate coordinates 40.273497, -81.568485). Wetland 1 measures approximately 0.58-acres and is located within the 100 year floodplain of the Tuscarawas River. This wetland has established within a well-defined depression within the forested riparian area along the Tuscarawas River. The dominant plant species within Wetland 1 consist of: silver maple (*Acer saccharinum*), panicled aster (*Symphotrichum lateriflorum*), wingstem (*Verbesina alternifolia*), and green-headed coneflower (*Rudbeckia laciniata*). Wetland hydrology indicators included water marks, inundation visible on aerial imagery, sparsely vegetated concave surface, drainage patterns, geomorphic position, and a positive FAC-neutral test. Hydric soil indicators observed in wetland one included a depleted matrix. This wetland achieved a score of 43 on the ORAM, making this a category 2 wetland. Wetland 1 is positioned within the 100 year floodplain of the lake and has a hydrological connection to the Tuscarawas River via overland sheetflow. Flooding and/or ponding from the river occurs within Wetland 1.

B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
