Identify TNW: **Big Darby Creek**.

Summarize rationale supporting determination: The Big Darby Creek is navigable in fact for a distance of 41.11 miles. The Big Darby Creek flows through two Metro Parks, including Batelle Darby Creek and Prairie Oaks Metro Park. These parks are owned and operated by the Columbus and Franklin County Metropolitan Park District. The Big Darby Creek is utilized by canoers at several locations. Specifically, an Upper Big Darby canoe access point has been constructed within the limits of the Prairie Oaks Metro Park at milepoint 41.11 of Big Darby Creek. This access point is located just south of Scioto & Darby Creek Road and just north of Wilson Ditch in Canaan Township, Madison County, Ohio. Canoers utilize the Big Darby from this point to its downstream point just before the confluence with the Scioto River, which is located just west of the City of Circleville, Pickaway County, Ohio. In 2007, Metro Parks documented that Prairie Oaks and Batelle Darby Creek parks had over 1 million visitors. In addition, at least one canoe livery is operated along the Big Darby and provides access points, as well as canoe pick-up/drop-off services at the Creek in Georgesville, Franklin County (within the Batelle Darby Creek Park limits), and Orient, Pickaway County. Therefore the Metro Parks provide easy access to Big Darby Creek for use by canoers and therefore offer recreational boating opportunities for local, interstate and/or foreign travelers. According to the Deputy Director of the Metro Parks, the majority of users at the parks include in-state residents; however, some out-of-state users do utilize the available recreational opportunities. In addition to use of this stream by canoers, the United States Fish and Wildlife Service has documented records of several federally-listed threatened and endangered species in Big Darby. These species include the clubshell mussel, the northern riffleshell mussel and the rayed bean mussel. Of particular importance in documenting a connection of these mussels to interstate commerce is the recent relocation of 1,700 northern riffleshell mussels from the Allegheny River in Forest County, Pennsylvania to the Big Darby Creek within the limits of Batelle Darby Creek Park. In conclusion, the Big Darby Creek is a TNW from its confluence with the Scioto River upstream to rivermile 41.11 in Madison County, Ohio.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
