This section of the canal is a continuous open waterbody that is historically navigable and currently supports canoe/boat traffic and thus is navigable in fact as well. The Ohio & Erie Canalway Coalition sponsors an annual 6 mile canoe trip from Nesmith Lake to downtown Akron on this stretch of the Ohio & Erie Canal. There are four public access points to the canal and towpath trail in this stretch of the canal and a large 100 car parking area is planned for Wilbeth Road access. The parking areas afford public access for canoes/boats to use the canal.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.




