Identify TNW: **Clear Fork Mohican River** .

Summarize rationale supporting determination: The Clear Fork Mohican River is navigable in fact for a distance of at least 8.36 miles. Pleasant Hill Lake is an impoundment of this river. The Ohio Department of Natural Resources has classified the Clear Fork as a Class I/II stream and as a popular stream for canoe paddling. This stream is utilized for canoeing/boating from at least the point where it enters Pleasant Hill Lake to its downstream point just before its confluence with the Black Fork Mohican River. Numerous canoe rentals and ramps provide access to the river, including Pleasant Hill Canoe Livery, Loudonville Canoe Livery, and Mohican River Canoe Livery. Pleasant Hill Lake covers an area of 850 acres and offers recreational opportunities for boaters with no limit on horsepower. One public boat launch ramp is located near the lake's marina. Easy access is provided to Pleasant Hill Lake and the Clear Fork Mohican River for use by boaters and canoes. Therefore recreational boating opportunities are provided for local, interstate and/or foreign travelers. In conclusion, the Clear Fork Mohican River is a TNW from its downstream point at its confluence with the Black Fork Mohican River to its upstream point just upstream of Pleasant Hill Lake.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
