Summarize rationale supporting determination: Tappan Lake is navigable-in-fact. The lake is located between Uhrichsville and Cadiz, Ohio on Little Stillwater Creek. The dam itself is owned and operated by the Corps of Engineers for flood control. The Muskingum Watershed Conservancy District (MWCD) is responsible for the operation and maintenance of the reservoir areas under its ownership and control including Tappan Lake Park. Amenities of the park include a boat launch ramp, over 500 campsites, a swimming beach, vacation and camper cabins, an activity center, playgrounds, and a trail connecting the park with Tappan Wetlands, a watchable wildlife area. Attendance at the park for 2007 was 680,154. MWCD has documentation on file at the Tappan Lake Park Office confirming the use of Tappan Lake for water-based interstate commerce by interstate travelers. In addition to the amenities available at Tappan Lake Park, the lake is highly publicized for boating, fishing, and hiking with a 399 horse power limit on boat motors. There are two additional public launch ramps and a marina on the lake. The marina offers boat sales and service, rentals, docking, fishing licenses, supplies, gas sales, boat and ski accessories, vacation cabin rentals, and a restaurant.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
