Explain: The 105.6 acre (ac) site contains features that have been evaluated for possible jurisdiction, including the Pond (10.5 ac), Wetland 1 (0.26 ac), and Stream 1 (84 lf). The closest jurisdictional stream is UNT to Twelvepole Creek an indirect tributary to the Ohio River and UNT Big Sandy River, a direct tributary to the Big Sandy River. The Pond was developed from airport construction and no

outlet is present. The Pond has Wetland Fringe and Stream 1 flows into the pond. None of the three features have distinct surface water connection to a water of the United States and are completely surrounded by uplands. Wetlands and streams mentioned above would not support interstate or foreign commerce interests, nor are they likely to contain any rare or endangered species. As such, these waters are designated and designed for the purposes defined by Section 402 of the Clean Water Act (CWA). Per 33 CFR 328.3(a)(8), the stream and wetlands are not waters of the United States.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
