The Area of Investigation (AOI) for the Switchback Loadout Extension Project is characterized by past/pre-SMCRA<sup>4</sup> mining activities (surface and underground), access roads, timbering, along with various forms of utility development. On 17 August 2015, this office received a Jurisdictional Determination request for the Switchback Loadout Extension Project, dated 13 August 2015 prepared by True Line, Inc. (TLI). Members from the United States (U.S.) Army Corps of Engineers (Corps), and TLI participated in an on-site field verification conducted on 4 November 2015.

Based on a review of the 13 August 2015 report submitted to our office, the on-site field verification conducted on 4 November 2015, and other data available to us, this office has determined that the AOI does not contain waters of the U.S. As referenced above, the AOI is characterized by pre-SMCRA mining activities, which has disrupted normal flow regimes and channel characteristics. Hydrology within the watershed has been pirated into underground mine workings, thus eliminating the presence of a defined bed and bank or an ordinary high water mark. Therefore, the AOI is not subject to regulation under Section 404 of the Clean Water Act.

Refer to the enclosed *Switchback Loadout Extension Stream Delineation Map* for a detailed depiction of the AOI. The approved JD follows our 2 December 2008 headquarters guidance entitled "Revised Guidance on Clean Water Act Jurisdiction Following the United States Supreme Court Decision in *Rapanos v. United States and Carabell v. United States*."

C. **SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
