On August 4, 2016, this office received a preconstruction notification (PCN), for the construction of the Blue Racer Midstream, MFS-1 Compressor Station Project. A Preliminary Jurisdictional Determination for Blue Racer Midstream, LLC., prepared by GAI Consultants was submitted along with the PCN identifying nine (9) perennial, intermittent, and ephemeral streams (Streams 1, 2, 3, 4a, 4, 5, 6, 7, 8, and 9) and nine (9) palustrine emergent (PEM) wetlands (Wetlands 1, 2, 3, 4, 5, 6, 7, 8, and 9) within the area of interest (AOI). After a desktop review of the on-site waters, members from the United States Army Corps of Engineers (Corps) conducted in an on-site field investigation on August 17, 2016.

Based on a review of the August 3, 2016 PCN submitted to our office, an on-site field verification conducted on August 17, 2016, and other data available to us, this office has determined that both jurisdictional and non-jurisdictional waters are present within the AOI; therefore, the *Blue Racer Midstream, MFS-1 Compressor Station Project* has been labeled with a preliminary jurisdictional determination (JD) boundary (i.e., Area of Interest – PJD) and an approved JD boundary (i.e., Area of Interest – AJD). The approved JD boundary contains nine (9) upland, non-jurisdictional Wetlands, (Wetlands 1, 2, 3, 4, 5, 6, 7, 8, and 9) as described below.

Wetland Areas: All Wetlands as indicated above are a result of several slope failures surrounding the project area, which have created small terraces along the hill slope that retain water during precipitation events. Indications of livestock disturbance have compacted the soils and impacted vegetation in these areas. Soil units mapped within the AOI included Gilpin-Peabody Complex, (GpD) 15-25 percent slopes and Gilpin-Peabody (GpF) 35 to 70 percent slopes. These soil units are well drained and consist of acid shale, siltstone, and sandstone. These soil series occur on hills, and presents a slip hazard, especially on slopes greater than 8 percent. No hydric soil indicators were present in the identified areas. Vegetation observed within the AOI did not have the characteristics of wetland vegetation and consisted of white clover, red clover, red fescue and rambler rose. This office has determined that Wetlands (1, 2, 3, 4, 5, 6, 7, 8, and 9) are upland, non-jurisdictional features, not subject to regulation under Section 404 of the Clean Water Act (CWA).

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
