Pond 1 (approximately 0.2 acre) and Pond 2 (approximately 0.3 acre) appear to be man-made, excavated water features that are deeper than 6.5 feet, not created by impoundment of a jurisdictional**

stream, and do not have a surface water connection to navigable water. Pond 1 and Pond 2 do not support wetland vegetation. Pond 1 and Pond 2 are not considered to be waters of the United States and are not subject to Section 404.). The drainage swale was likely created as a result of farming activity and development of the surrounding area and has no surface water connections to waters of the United States. Drainage Swale 1 does not carry a relatively permanent flow of water, does not exhibit an ordinary high water mark or defined bed and bank or wetland characteristics. Additionally, the non-jurisdictional drainage swale is discontinuous and is heavily vegetated with upland herbaceous species in several locations. Therefore, drainage swale (Swale 1) is not a water of the United States.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
