The West Fork II AML Enhancement Area of Interest (AOI) is characterized by past/pre SMCRA<sup>4</sup> underground and surface mining activities, access roads, slips, and highwalls. Past mining activities have significantly altered the natural topography within the AOI. On 24 February 2016, this office received an application for a Department of Army (DA) Nationwide Permit No. 49 titled *West Fork II Abandoned Mine Land Enhancement Project*, dated 11 February 2016 and prepared by Ohio Department of Natural Resources – Division of Mineral Resources Management (ODNR-DMRM) on behalf of B&N Coal Company. During this review of the project, the Corps requested additional information required to accurately describe and delineate waters within the West Fork II AOI. Additional information was received by our office 7 April 2016.

Based on a review of the 11 February 2016 report submitted to our office, additional information received 7 April 2016, and other data available to us, this office has determined that only non-jurisdictional waters are present within the approved jurisdictional determination (JD) boundary. The approved JD boundary contains three (3) isolated, non-jurisdictional open water features (0.391 acre (ac)), and six (6) isolated, non-jurisdictional wetlands (0.092 acres).

**PP-24, PP-33, and PP-35 (0.391 ac):** PP-24, PP-33, and PP-35 are depressional open water features with wetland fringes that are located on a pit floor from past mining operations. The features are depressions and surrounded entirely by uplands. Hydrology enters the features from seeps discharging from coal seams. The open water features do not possess a hydrologic surface or consolidated subsurface connection to a water of the U.S. Therefore, PP-24, PP-33, and PP-35 are isolated, non-jurisdictional features, not subject to regulation under Section 404 of the CWA.

**SZ-26B (0.01 ac), SZ-30B (0.001 ac), and SZ-30C (0.001 ac):** SZ-26B, SZ-30B, and SZ-30C are seep zones that discharge from coal seams located on-site. SZ-26B discharges into PP-24 which is isolated. SZ-30B and SZ-30C discharge into PP-33 which is isolated. The features do not possess a hydrologic surface connection or consolidated subsurface connection to a water of the U.S. Therefore SZ-26B, SZ-30B and SZ-30C are isolated, non-jurisdictional features, not subject to regulation under Section 404 of the CWA.

The approved JD follows our 2 December 2008 headquarters guidance entitled "Revised Guidance on Clean Water Act Jurisdiction Following the United States Supreme Court Decision in *Rapanos v. United States* and *Carabell v. United States*."

If the waterbody<sup>4</sup> is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. **SIGNIFICANT NEXUS DETERMINATION**

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:**
