Wetland 1 - 0.279-acre, is a palustrine emergent wetland that formed in a topographic depression in the western portion of the project site. It is dominated by squarrose sedge, calico aster, and reed canarygrass. Wetland 1 is a low quality Category 1 wetland based on the ORAM score of 12. The soils at Wetland 1 were heterogeneous within 0-5 inches of the surface with a color palate of 10YR 6/2 and 10YR 5/1 clay

loam with a dual matrix of redox features (10YR 4/6) within approximately 10 percent of the soil. Wetland hydrology indicators included sparsely vegetated concave surface, surface soil cracks, drainage patterns, saturation visible on aerial imagery, geomorphic position, and FAC-neutral test. Wetland 1 is completely surrounded by uplands with no hydrologic connection to waters of the United States.

Wetland 2 - 0.097-acre, is a palustrine emergent wetland that formed in a topographic depression in the western portion of the project site. It is dominated by yellow foxtail, reed canarygrass, and calico aster. Wetland 2 is a low quality Category 1 wetland based on the ORAM score of 11. The soils at Wetland 2 were heterogeneous within 0-10 inches of the surface with a color palette of 10YR 4/1 and 10YR 5/2 clay loam with a dual matrix of redox features (10YR 4/6 and 10YR 6/2) within approximately 20 percent of the soil. Wetland hydrology indicators included surface soil cracks, drainage patterns, saturation visible on aerial imagery, geomorphic position, and FAC-neutral test. Wetland 2 is completely surrounded by uplands with no hydrologic connection to waters of the United States.

Wetland 3 - 0.052-acre, is a palustrine emergent wetland that formed in a topographic depression in the western portion of the project site. It is dominated by cocksbur grass and reed canarygrass. Wetland 3 is a low quality Category 1 wetland based on the ORAM score of 11. The soils at Wetland 3 were heterogeneous within 0-10 inches of the surface with a color palette of 10YR 4/1 clay loam with a dual matrix of redox features (10YR 5/6 and 10YR 5/1) within approximately 20 percent of the soil. Wetland hydrology indicators included surface soil cracks, drainage patterns, saturation visible on aerial imagery, geomorphic position, and FAC-neutral test. Wetland 3 is completely surrounded by uplands with no hydrologic connection to waters of the United States.

Wetland 5 - 0.007-acre, is a palustrine emergent wetland that formed in a topographic depression in the central portion of the project site. It is dominated by reed canarygrass, squarrose sedge, and slender rush. Wetland 5 is a low quality Category 1 wetland based on the ORAM score of 10. The soils at Wetland 5 were heterogeneous within 0-8 inches of the surface with a color palette of 10YR 6/1 clay loam with a dual matrix of redox features (10YR 4/6) within approximately 20 percent of the soil. Wetland hydrology indicators included saturation visible on aerial imagery and FAC-neutral test. Wetland 5 is completely surrounded by uplands with no hydrologic connection to waters of the United States.

Stream 1 (228 linear feet) forms naturally within the western portion of the subject site. The feature flows in a northern direction for approximately 228 linear feet before its defined features diminish and discharge into a maintained lawn. It was determined that this feature lacks a surface water connection to tributary systems of a traditional navigable water. Therefore, this feature does not meet the criteria of a water of the United States in accordance with the definitions outlined in 33 CFR 328.3(a).

Ditch 1 (176 linear feet) is vegetated drainageway is present within the site and was constructed entirely in uplands, lacks a defined bed and bank, an ordinary high water mark (OHWM), and wetland characteristics. Therefore, it is not a water of the United States.

Erosional Feature 1 (53 linear feet) is drainageway present within the site and is located entirely in uplands, lacks a defined bed and bank, an OHWM, and wetland characteristics. Therefore, it is not a water of the United States.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
