agricultural fields with industrial developments to the east. This feature does not have a distinct surface water connection to another potential water of the United States. The closest jurisdictional stream is approximately 2,300 feet away. This feature would not support interstate or foreign commerce interest, nor does it contain any rare or threatened and endangered species. Therefore, this feature is not a jurisdictional water of the United States. Wetland 2 (0.053 acre) is completely surrounded by uplands, with no surface water connection to a water of the United States, and no nexus to interstate or foreign commerce. The land surrounding this wetland consists of open agricultural fields with forested areas located in the west. This feature does not have a distinct surface water connection to another potential water of the United States. The closest jurisdictional stream is approximately 450 feet away. This feature would not support interstate or foreign commerce interest, nor does it contain any rare or threatened and endangered species. Therefore, this feature is not a jurisdictional water of the United States. Wetland 3 (0.354 acre) is completely surrounded by uplands, with no surface water connection to a water of the United States, and no nexus to interstate or foreign commerce. The land surrounding this wetland consists of open agricultural fields with forested areas located in the west. This feature does not have a distinct surface water connection to another potential water of the United States. The closest jurisdictional stream is approximately 400 feet away. This feature would not support interstate or foreign commerce interest, nor does it contain any rare or threatened and endangered species. Therefore, this feature is not a jurisdictional water of the United States. Wetland 4 (0.13 acre) is completely surrounded by uplands, with no surface water connection to a water of the United States, and no nexus to interstate or foreign commerce. The land surrounding this wetland consists of open agricultural fields. This feature does not have a distinct surface water connection to another potential water of the United States. The closest jurisdictional stream is approximately 650 feet away. This feature would not support interstate or foreign commerce interest, nor does it contain any rare or threatened and endangered species. Therefore, this feature is not a jurisdictional water of the United States. Wetland 5 (0.069 acre) is completely surrounded by uplands, with no surface water connection to a water of the United States, and no nexus to interstate or foreign commerce. The land surrounding this wetland consists of open agricultural fields with scrub-shrub and forested areas located to the west. This feature does not have a distinct surface water connection to another potential water of the United States. The closest jurisdictional stream is approximately 2,000 feet away. This feature would not support interstate or foreign commerce interest, nor does it contain any rare or threatened and endangered species. Therefore, this feature is not a jurisdictional water of the United States. Wetland 6 (0.033 acre) is completely surrounded by uplands, with no surface water connection to a water of the United States, and no nexus to interstate or foreign commerce. The land surrounding this wetland consists of scrub-shrub and forested areas to the west and industrial developments to the east. This feature does not have a distinct surface water connection to another potential water of the United States. The closest jurisdictional stream is approximately 2,150 feet away. This feature would not support interstate or foreign commerce interest, nor does it contain any rare or threatened and endangered species. Therefore, this feature is not a jurisdictional water of the United States. Wetland 8 (0.056 acre) is completely surrounded by uplands, with no surface water connection to a water of the United States, and no nexus to interstate or foreign commerce. The land surrounding this wetland consists of open agricultural fields. This feature does not have a distinct surface water connection to another potential water of the United States. The closest jurisdictional stream is approximately 370 feet away. This feature would not support interstate or foreign commerce interest, nor does it contain any rare or threatened and endangered species. Therefore, this feature is not a jurisdictional water of the United States. Wetland 9 (0.096 acre) is completely surrounded by uplands, with no surface water connection to a water of the United States, and no nexus to interstate or foreign commerce. The land surrounding this wetland consists of open agricultural fields with scrub-shrub and forested areas located to the south. This feature does not have a distinct surface water connection to another potential water of the United States. The closest jurisdictional stream is approximately 1,470 feet away. This feature would not support interstate or foreign commerce interest, nor does it contain any rare or threatened and endangered species. Therefore, this feature is not a jurisdictional water of the United States. Wetland 10 (0.050 acre) is completely surrounded by uplands, with no surface water connection to a water of the United States, and no nexus to interstate or foreign commerce. The land surrounding this wetland consists of open agricultural fields with scrub-shrub and forested areas to the north. This feature does not have a distinct surface water connection to another potential water of the United States. The closest jurisdictional stream is approximately 1,270 feet away. This feature would not support interstate or foreign commerce interest, nor does it contain any rare or threatened and endangered species. Therefore, this feature is not a jurisdictional water of the United States.

A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to carry pollutants or flood waters to TNWs, or to reduce the amount of pollutants or flood waters reaching a TNW?
- Does the tributary, in combination with its adjacent wetlands (if any), provide habitat and lifecycle support functions for fish and other species, such as feeding, nesting, spawning, or rearing young for species that are present in the TNW?
