Explain: **The 22.15-acre site contains features that have been evaluated for possible jurisdiction, including Wetland A (0.62 acre). Wetland A is a palustrine forested wetland located in a depression in the northeastern portion of the site. Wetland A is located in a topographic depression, with no apparent inlet or outlet, is completely surrounded by uplands, and no distinct surface water connection to the tributary system of a water of the United States. Wetland A neither support interstate or foreign commerce interests nor contain any rare or endangered species. Therefore, this office has determined that Wetlands A is an isolated, non-jurisdictional feature, and not subject**

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- Does the tributary, in combination with its adjacent wetlands (if any), have other relationships to the physical, chemical, or biological integrity of the TNW?
