## **SECTION III: CWA ANALYSIS**

### **A. TNWs AND WETLANDS ADJACENT TO TNWs**

#### **1. TNW**

The Portage Lakes are a Traditionally Navigable network of canals and reservoirs created in 1825 to supply water to the canal system. The lakes are well known for the fishing, boating, camping, picnicking, swimming and other recreational opportunities. The lakes have hosted numerous fishing tournaments, including the American Bass Fishing Trail, the Midwest Pro Bass Series, and the NBC Championship Pro Bass Series 2006. A state park is also operated on the lakes, by the Ohio Department of Natural Resources. The recreational opportunities and fishing tournaments promote interstate commerce to the lakes. The Portage Lakes are used, and have been used, for interstate commerce. On the lakes is a state park, operated through Ohio Department of Natural Resources. The park provides camping, swimming, as well as public boat access to the lakes. Additionally, the lakes hold several fishing tournaments throughout the year. These tournaments include the Northern Open Anglers Association, the American Bass Fishing Trail, the Midwest Pro Bass Series, NBC Championship Pro Bass Series 2006, and the X-Series Bass Fishing Tournament. Such tournaments and recreational opportunities attract individuals outside of Ohio, thus confirming interstate commerce. To accommodate tourists, there are numerous boat rental and outfitters along the lake.

Nimisila Reservoir was constructed in 1936 to supply water in the Portage Lakes for industrial use. Normally, the reservoir discharges through an uncontrolled spillway into the Tuscarawas River watershed. However, water can be released into the Portage Lakes system through two gated outlets located on the west side of the reservoir. Alternatively, water can also be pumped from the Portage Lakes into the Nimisila Reservoir via a pump located at the upper end of Turkeyfoot Lake. Nimisila Reservoir is part of the Portage Lakes State Park. The maximum depth of the lake is 30 feet. Fish populations are managed by the Ohio Division of Wildlife but boat access is limited to those with electric motors.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
