C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The reach was once connected to a RPW, but disturbance has caused the RPW to take a different route.

These wetlands were verified in the field by the Corps. These features are non-jurisdictional because they do not exhibit a hydrologic surface connection or consolidated subsurface connection to the tributary system. A prelaw highwall and bench road were field investigated and there was no indication of flow from the wetlands to any water of the United States. These wetlands formed in depressions on the bench.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form contains all the isolated/non-jurisdictional waters where there is no obvious indication of overland flow from any of the identified wetlands. No obvious hydrologic connection to the tributary system was noted during a field inspection. There was no indication of commerce associated with the wetlands. The property is privately owned. They are not predicted to be used as habitat for endangered species. There is no public access to the site.

The jurisdictional determination is based on guidance that became effective on May 29, 1998 as a result of the United States v. Wilson, 133 F. 3d 251 (4th Cir. 1997), the December 2, 2008 Corps and USEPA headquarter guidance entitled, "Revised Guidance on Clean Water Act Jurisdiction Following the U.S. Supreme Courts Decision in Rapanos v. United States and Carabell v. United States," and the January 28, 2008 Corps memorandum regarding coordination on jurisdictional determinations.
