Summarize overall biological, chemical and physical functions being performed: Wetland A and Wetland B were assessed for jurisdiction after impacts had occurred. Based on the best available information and best professional judgment, Wetland A and Wetland B were determined to provide more than a speculative or insubstantial effect on water quality in the Scioto River.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Spain Creek in combination with Wetland A and Wetland B provide more than an insubstantial or speculative effect on the water quality of the Scioto River, a TNW. Therefore, Wetland A and Wetland B are determined to have a significant nexus on the TNW.
