macroinvertebrates, amphibians and fish living near or within the nearest TNW. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: RR#26-St-G4B3 is located 30 or more river miles from the nearest TNW and exhibits water flow only during precipitation events. It has been determined that it is unlikely that this stream contributes pollutants and flood water to the nearest TNW, as this stream has a natural channel that appears to not have been impacted by previous surface mining. It has been determined that it is unlikely that this stream provides permanent aquatic habitat, or spawning habitat, for aquatic macroinvertebrates, amphibians and fish living near or within the nearest TNW. It has been determined that it is unlikely that this stream transfers stored nutrients and organic carbon to help support food webs within the nearest TNW. In conclusion, based upon the physical, chemical, and biological information provided for this stream, it has been determined that RR#26-St-G4B3 does not have a significant nexus to the nearest TNW, the Ohio River.
