NPDES permit WV1015869. The existing wastewater treatment system consists of two ponds, 4 and 4A, that have been identified as OPW 2 and OPW 3, respectively. OPW 2 and OPW 3 are connected by a 269-foot long portion of Little Ugly Branch that is a rip-rap channel, and exhibits intermittent flow. The total length of Little Ugly Branch that is included in the wastewater treatment system is 851 feet, and if the wastewater treatment system is in place and functioning under a valid NPDES permit, it is exempt from regulation by the USACE under the Clean Water Act. However, upon removal and reclamation of the wastewater treatment system, and/or if any portion of the 851-foot long reach no longer functions as a wastewater treatment system, then the USACE would assert jurisdiction over this reach. As such, the placement of fill material below the ordinary high water mark (OHWM) would be regulated under Section 404 of the Clean Water Act.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: An on-site field investigation was conducted on December 3, 2010 with representatives from the USACE and DEI. The West Virginia Department of Environmental Protection (WVDEP) declined to participate in the field investigation. During the field investigation the USACE requested revisions needed to accurately describe and delineate waters on site. These revisions were received from DEI on behalf of Eagle on December 15, 2010. An approved jurisdictional determination (AJD) was prepared to document the presence of jurisdictional and non-jurisdictional waters within the Delineation Boundary. The attached Stream Delineation Map identifies the limits of the delineation, relevant reaches and waters for this AJD.
