Summarize rationale supporting determination: An approximately 72-mile section of the Whitewater River is navigable-in-fact.

Canoe access points are available along the river and detailed by both the Indiana and Ohio Departments of Natural Resources (DNR) on their boating access websites. On their website, the American Whitewater organization describes a Whitewater River canoe trip with put-in and take-out points on the Whitewater River in Indiana, with an alternate take-out on the Great Miami River at the Lost Bridge off River Road in Elizabethtown, Ohio. The navigable reach flows through Wayne, Fayette, Franklin and Dearborn Counties in Indiana and Hamilton County in Ohio. Three canoe liveries operate commercially on the Whitewater River, providing canoe and kayak rentals with shuttle service; two of the liveries are located in Indiana and one is located in Ohio. Six public access points on the Whitewater River in Indiana are depicted on a map created by the Indiana DNR; one of the access points is on the state line. Two public access points are depicted on a map created by the Ohio DNR, including the access on the state line. Riverside campsites, including primitive campsites and group campsites, are available from Morgan's Brookville Canoe and Outdoor Adventures and from Whitewater Canoe Rental. There is documented use of the Whitewater River for water-based interstate commerce by interstate travelers. The coordinates for the upper limits of the TNW reach are 29.8153 N 85.0142 W (Crietz Park in Cambridge City, Wayne County Indiana); the coordinates for the lower limits at the confluence with the Great Miami River are 39.1643 N 84.7866 W (at River Mile 6.0 northeast of Elizabethtown, Hamilton County, Ohio).

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to carry pollutants or flood waters to TNWs, or to reduce the amount of pollutants or flood waters reaching a TNW?
