Identify TNW: **Kokosing River.**

Summarize rationale supporting determination: The Kokosing River is a State Scenic River. The Ohio Environmental Protection Agency (Ohio EPA) has assigned the Kokosing River an antidegradation category of Outstanding State Water, and an aquatic life use designation of Exceptional Warmwater Habitat. It is navigable-in-fact for a distance of approximately 35.1 miles and flows, in part, along the Kokosing Gap Trail, a paved, 14-mile recreational trail built on a former Pennsylvania Railroad line with endpoints in Mount Vernon and Danville, Knox County, Ohio. According to the Ohio Department of Natural Resources, the Kokosing State Scenic River is utilized by many anglers, canoers, kayakers, wildlife viewers, and waders. According to Ohio EPA the Kokosing River has exceptional macroinvertebrate and fish communities and may include suitable habitat for the eastern hellbender (*Cryptobranchus a. alleganiensis*), a federally-listed species of concern and an Ohio endangered species. The Kokosing River Water Trail is an approximate 28-mile trail of deep pools, high quality riffles, short rapids, and scenic rock cliffs from a portage access point at Riverside Park in Mt. Vernon downstream to the Kokosing River confluence with the Mohican River in Newcastle Township, Coshocton County, Ohio. There are nine portage access points altogether along the Kokosing River Water Trail. At least one canoe livery with pick-up/drop-off services, identified as Kokosing Valley Camp and Canoe, is operated along the Kokosing River in Howard, Ohio. According to the Ohio Department of Natural Resources - Division of Watercraft, during the spring months and other periods of high flows, the Kokosing River is navigable from its intersection with Sparta Road approximately one mile southwest of Fredricktown, Knox County, Ohio downstream to Riverside Park in Mt. Vernon. In view of the above, there is easy access to the Kokosing River for both local and interstate tourists. In conclusion, the Kokosing River is a TNW from its confluence with the Mohican River in Newcastle Township, Coshocton County, Ohio upstream to River Mile 35.1 in Wayne Township, Knox County, Ohio.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
