The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). The Summit County Soil Survey mapping shows an intermittent stream/drainage in the vicinity of the current stream; however, the flow of the stream and drainage patterns on-site have been modified due to the various land use activities over the years. Based on the consultant's observations during different days and years and on the observations in the field during the 2 July 2012 Corps site visit, this stream carries water during/after precipitation events (rain or snow melt).

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

Stream A is connected to the tributary system of the Tuscarawas River, TNW. Stream A is a primary headwater habitat stream and received a score of 40 based on Ohio EPA methods. Stream A receives surface water runoff from the surrounding airport and roadways and has the capacity to carry flood waters, contribute to the capacity of the system to transfer nutrients and organic carbon that support downstream food webs and reduce the amount of pollutants reaching the TNW. Therefore, Stream A is determined to have a significant nexus with the Tuscarawas River, a TNW.
