☒ Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Isolated Wetlands E, F, K, L, P, and W (0.221 acre combined) appear to be small, isolated pockets of wetlands. With the exception of Wetland W (which is located in a forested area), all of the isolated wetlands are located in old fields. They are completely surrounded by uplands with no surface connection to a water of the U.S. In addition to being hydrologically isolated from a surface tributary system, the wetlands do not appear to support interstate or foreign commerce interests. The wetlands are not used to irrigate crops nor do they appear to have any recreational value supporting interstate or foreign commerce. In addition, the wetlands do not contain any rare or endangered species.**

The 0.130 acre pond is an artificial waterbody created by excavating dry land to collect water either for stock watering purposes or aesthetic reasons and is not a water of the U.S.

Retention Basin 1 with non-jurisdictional swale are storm water features created by excavating an upland area to achieve required storage capacity for stormwater detention associated with a residential subdivision located to the west of the subject site. The pond and swale did not exist on the site in 2001 when the Corps verified a past wetland delineation report for the site. The property has been under the same ownership since that time and the owner was responsible for the establishment of the adjoining residential subdivision. Documentation provided by the owner indicates the features were constructed and are currently used for stormwater detention. As such, they are not waters of the U.S.

Retention Basin 3 is a stormwater pond created in the fall of 2011 by excavating an upland area to achieve required storage capacity for stormwater detention associated with an institutional development located to the west of the subject site. Retention Basin 3 is therefore not a water of the U.S.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Isolated Wetlands E, F, K, L, P, and W (0.221 acre combined) appear to be small, isolated pockets of wetlands. With the exception of Wetland W (which is located in a forested area), all of the isolated wetlands are located in old fields. They are completely surrounded by uplands with no surface connection to a water of the U.S. In addition to being hydrologically isolated from a surface tributary system, the wetlands do not appear to support interstate or foreign commerce interests. The wetlands are not used to irrigate crops nor do they appear to have any recreational value supporting interstate or foreign commerce. In addition, the wetlands do not contain any rare or endangered species. The 0.130 acre pond is an artificial waterbody created by excavating dry land to collect water either for stock watering purposes or aesthetic reasons and is not a water of the U.S. Retention Basin 1 with non-jurisdictional swale are stormwater features created by excavating an upland area to achieve required storage capacity for stormwater detention associated with a residential subdivision located to the west of the subject site. The features did not exist on the site in 2001 when the Corps verified a past wetland delineation report for the site. The property has been under the same ownership since that time and the owner was responsible for the establishment of the adjoining residential subdivision. Documentation provided by the owner indicates the features were constructed and are currently used for storm water detention. As such, they are not waters of the U.S. Retention Basin 3 is a stormwater pond created in the fall of 2011 by excavating an upland area to achieve required storage capacity for stormwater detention associated with an institutional development located to the west of the subject site. Retention Basin 3 is therefore not a water of the U.S.
