This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. Summarize overall biological, chemical and physical functions being performed: Wetland Q acts to filter runoff from surrounding uplands before entering RR4 and also transfers nutrients to the stream. Further biological, chemical, and physical functions being performed would be associated with Wetland Q2 as discussed above.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The stream is classified as a Class I stream with a score of 19 using Ohio EPA's Headwater Habitat Evaluation Index (HHEI) under Ohio EPA's Field Evaluation Manual for Ohio's Primary Headwater Habitat Streams (Ohio EPA 2005). According to Ohio EPA's research, Class I streams process nutrients and sediment, dissipate energy, maintain stream energy dynamics, and maintain and protect downstream beneficial uses. Stream 4 originates from within Wetland Q2, a 0.184 acre palustrine shrub/scrub and emergent wetland. Wetland Q scored a 51.5 (equivalent to Category 2 or medium quality) using Ohio EPA's ORAM. The wetland is a source of hydrology for and provides nutrients to the stream. When Stream 4 is considered in combination with Wetland Q2, they provide more than a speculative or insubstantial effect on the chemical, physical, and biological integrity of the receiving TNW, the Tuscarawas River. Therefore, Stream 4 and abutting Wetland Q2 is determined to have a significant nexus on the TNW.
