the riparian zone. NJD 1, NJD 2, DC1 and DC2 do not present a hydrologic connection to waters of the U.S., and do not have a nexus to interstate or foreign commerce. The streams do not support commercial fish species and are not used for agricultural irrigation. The closest jurisdictional stream (Crane Creek) to the above listed streams is greater than 1,000 feet away. Therefore, Streams NJD1, NJD 2, DC 1 and DC 2 are not jurisdictional waters of the U.S. Flume 1 (840 lf) and Flume 3 (205 lf) are surrounded by scrub shrub forest, and lack an ordinary high water mark (OHWM) and a defined bed and bank. Flumes 1 and 3 do not present a hydrologic connection to waters of the U.S., and do not have a nexus to interstate or foreign commerce.

Erosional Feature 1 (535 lf) and the constructed swale (353 lf) are surrounded by scrub shrub forest, lack an OHWM and do not present a hydrologic connection to waters of the U.S. These features do not have a nexus to interstate or foreign commerce. Additionally, neither feature supports commercial fish species nor are used for agricultural irrigation. There was no evidence of flow from the erosional feature or the constructed swale into Crane Creek, the nearest jurisdictional water.

Open Water 1 (0.25 acre) was not observed to convey flow and is completely surrounded by forest. Wetland 1 is an isolated, palustrine emergent (PEM) wetland that is surrounded by scrub shrub forest. Open Water 1 and Wetland 1 do not present a hydrologic connection to waters of the U.S. These features do not have a nexus to interstate or foreign commerce. Additionally, neither feature supports commercial fish species nor are used for agricultural irrigation.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Therefore, Streams NJD1, NJD 2, DC 1 and DC 2 are not jurisdictional waters of the U.S. Flume 1 (840 lf) and Flume 3 (205 lf) are surrounded by scrub shrub forest, and lack an ordinary high water mark (OHWM) and a defined bed and bank. Flumes 1 and 3 do not present a hydrologic connection to waters of the U.S., and do not have a nexus to interstate or foreign commerce.

Erosional Feature 1 (535 lf) and the constructed swale (353 lf) are surrounded by scrub shrub forest, lack an OHWM and do not present a hydrologic connection to waters of the U.S. These features do not have a nexus to interstate or foreign commerce. Additionally, neither feature supports commercial fish species nor are used for agricultural irrigation. There was no evidence of flow from the erosional feature or the constructed swale into Crane Creek, the nearest jurisdictional water.

Open Water 1 (0.25 acre) was not observed to convey flow and is completely surrounded by forest. Wetland 1 is an isolated, palustrine emergent (PEM) wetland that is surrounded by scrub shrub forest. Open Water 1 and Wetland 1 do not present a hydrologic connection to waters of the U.S. These features do not have a nexus to interstate or foreign commerce. Additionally, neither feature supports commercial fish species nor are used for agricultural irrigation.

The aforementioned waters will be coordinated with the Corps HQ and USEPA Region for isolated waters coordination in accordance with Corps and USEPA headquarters guidance entitled, “Revised Guidance on Clean Water Act Jurisdiction Following the U.S. Supreme Courts Decision in Rapanos v. United States and Carabell v. United States,” and the 28 January 2008 Corps Memorandum regarding coordination on jurisdictional determinations.
