- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The site contains two wetlands (Wetlands A and B) totaling 0.04-acre. Wetland A (approximately 0.03-acre) is a pulustrine, emergent wetland located in a depression in the central portion of the site. Wetland B (approximately 0.01-acre) is a pulustrine, emergent wetland located in a depression in the east/central portion of the site. Wetlands A and B are located in depressions, with no apparent inlet or outlet and no distinct surface water connection to Dicks Creek. Wetlands A and B are formed in topographic depressions and are completely surrounded by uplands. Wetlands A and B do not have a distinct surface water connection to waters of the United States. These wetlands neither support interstate or foreign commerce interests nor contain any rare or endangered species. Therefore, Wetlands A and B totaling approximately 0.04-acre are not jurisdictional waters of the United States.**

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:**

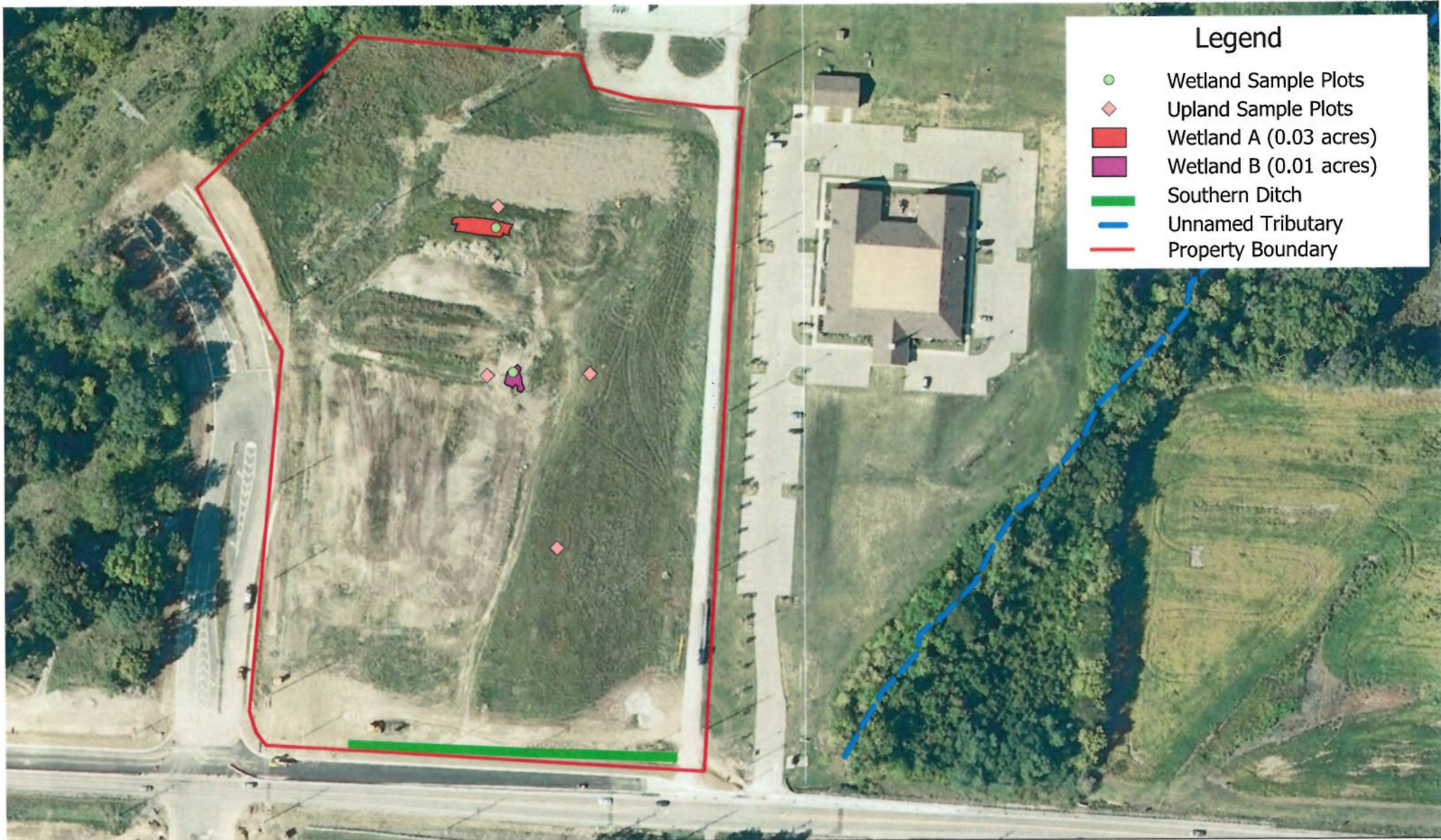

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The 10.4-acre site is located north of Ohio Route 122, between Atrium Boulevard and Babson Court, in the City of Middletown, Warren County, Ohio. The site is bordered by Atrium Road on the west, State Route 122 on the south, an institutional driveway on the east, and Dicks Creek riparian zone to the north. The site contains no intermittent, ephemeral, or perennial streams. The closest mapped blue line stream (Dicks Creek) is approximately 250 feet to the northwest. Historically, the entire site has been used for agricultural crops until it was cleared and graded for development in circa 2008, but has remained a vacant land site after the initial development was cancelled. The following soil types are mapped as occurring within the site: Dana silt Loam (DaB), Xenia silt loam (XeA), and Russell-Miamian silt loam (RvB2). All three are listed as hydric soils in Warren County, Ohio according to the United States Department of Agriculture (USDA) Web Soil Survey. The National Wetlands Inventory Map (NWI) identifies no wetlands within the proposed project area.

Wetlands A and B are surrounded by uplands, with no hydrologic connection to the tributary system. There is no indication of interstate or foreign commerce associated with the wetlands, and the wetlands do not provide suitable habitat for endangered species. This determination was coordinated with the Corps HQ and USEPA Region 5 for isolated waters coordination, in accordance with Corps and USEPA headquarters guidance entitled, "Revised Guidance on Clean Water Act Jurisdiction Following the U.S. Supreme Courts Decision in Rapanos v. United States and Carabell v. United States," and the 28 January 2008 Corps Memorandum regarding coordination on jurisdictional determinations. This JD is not associated with a pending application and is for informational purposes only.
