The Area 1 Project delineation boundary is mostly forested with incidental access roads associated with gas wells and past timber harvest/removal. There is also evidence of past/pre-SMCRA⁴ mining activities (i.e., high walls, strip benches, catch roads).

Based on a review of the March 22, 2016 report submitted to our office, a desktop review of the location, and other data available to us, this office has determined that two non-jurisdictional Palustine emergent (PEM) wetlands are located within the area of interest (AOI). Wetlands 1 and 2 are completely surrounded by uplands and do not present a hydrologic connection to a surface tributary stream. In addition to being hydrological isolated from a surface tributary system, Wetland 1 and 2 do not support interstate or foreign commerce interests nor do they contain rare or endangered species. The property surrounding both wetlands exhibits post mining operations along with existing gas well roads and ATV trails.

Based on the above referenced information, this office has determined that Wetlands 1 and 2 are isolated, non-jurisdictional features, not subject to regulation under Section 404 of the Clean Water Act (CWA). The aforementioned non-jurisdictional determination is based on guidance that became effective on 29 May 1998. This guidance was the result of the U.S. v. Wilson, 133 F. 3d 251 (4th Cir. 1997).

relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody⁵ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
