- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **One (1) Ephemeral Stream and one (1) open water.** Approximately 2,949 linear feet of one (1) ephemeral channel is present on-site. The ephemeral channel showed no signs of leaf and debris disturbance and no hydrologic surface or consolidated subsurface connection to a surface tributary system. The closed tributary system is an intermittent stream located approximately 415 feet downstream from the ephemeral channel. The ephemeral channel exhibited a bed and bank with deep ravines with rocky outcrops. One (1) open water is present and is completely surrounded by uplands and does not present a hydrologic connection to a surface tributary stream. The open water and ephemeral channel do not exhibit a hydrologic surface or consolidated subsurface connection to waters of the U.S. Therefore, these features are not considered jurisdictional waters of the U.S. and are not subject to regulation under Section 404 of the Clean Water Act.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
