The Tri-State Solar Panel Project site consists almost entirely of one (1) non-jurisdictional, palustrine emergent wetland with some scrub-shrub habitat intermixed. It is located immediately off of Highway 60 with a developed area near Interstate 75 to its east and south, and agricultural fields to its west and north. On January 12, 2016, this office received a *Preliminary Jurisdictional Determination Report* for the Tri-State Solar Panel Project, submitted by STF Group, Inc. (STF) on behalf of Tri-State Solar/Wind Energy, LLC (Tri-State). Members from the United States (U.S.) Army Corps of Engineers (Corps) and a representative from Tri-State participated in an on-site field verification conducted on February 4, 2016. During this investigation, the Corps did not observe the presence of any waters of the U.S. on the project site.

Based on a review of the review of the January 12, 2016 PCN submitted to our office, on-site field verification on February, the enclosed *Project Site Map* has been labeled with an approved JD boundary. The approved JD boundary contains one (1) isolated, non-jurisdictional, palustrine emergent (PEM) wetland (Wetland 1), approximately 13 acres in area.

Wetland 1: Wetland 1 (approximately 13 acres) is a non-jurisdictional, PEM wetland that makes up the majority of the total project site (approximately 14.96 acres). The nearest water of the U.S. is approximately 1,400 linear feet to the west of Wetland 1. Wetland 1 does not exhibit a hydrologic surface or consolidated subsurface connection to a water of the U.S. Based on the above referenced information, this office has determined that Wetland 1 is an isolated, non-jurisdictional water feature and is not subject to regulation under Section 404 of the Clean Water Act (CWA).

The wetland did not possess a hydrologic surface or consolidated subsurface connection to a water of the U.S. and is therefore considered non-jurisdictional and is not subject to regulation under Section 404 of the CWA. The aforementioned non-jurisdictional determination is based on guidance that became effective on 29 May 1998. This guidance was the result of the *U.S. v. Wilson*, 133 F. 3d 251 (4th Cir. 1997). Isolated wetlands and stream reaches may be subject to regulation by the West Virginia Department of Environmental Protection (WVDEP).

The approved JD follows our 2 December 2008 headquarters guidance entitled "Revised Guidance on Clean Water Act Jurisdiction Following the United States Supreme Court Decision in *Rapanos v. United States* and *Carabell v. United States*."

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
