is approximately 88 feet in length, and Ditch 12, which is approximately 59 feet in length, are located near Harmony Church Road (40.197069, -82.676989). According to the site photographs, Ditch 9, 10, 11, and 12, do not have a defined bed and bank or ordinary high water marks. These features are not considered waters of the United States. The closest jurisdictional stream is located approximately 40 linear feet to the west of Ditch 9 and 10, and approximately 30 linear feet to the east of Ditch 11 and 12. Based on this information, Ditch 9, 10, 11, 12 are not jurisdictional waters of the United States.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to carry pollutants or flood waters to TNWs, or to reduce the amount of pollutants or flood waters reaching a TNW?
