Wetlands A, B, C, D, E, F, G, H and I, totaling 0.45 acre, are isolated wetlands that are completely surrounded by uplands and are not connected to the**

The Corps determined one storm water basin depicted as waste treatment system 1, totaling 0.95 acre, is present within the review area and is a waste treatment system designed to meet the requirements of the Clean Water Act. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

B. ADDITIONAL COMMENTS TO SUPPORT JD: The 19.5-acre project site is comprised primarily of old field habitat and a small wooded area and is relatively flat terrain. The surrounding area includes residential development, a golf course, and a wooded area. No streams are present on-site and the nearest stream, an unnamed tributary to Buck Run, is located off-site and approximately 0.5 mile south of the project site . A storm water management system was constructed on the parcel between years 1995-2000, in association with an adjacent development "Milford View" Subdivision. Across the parcel, surface water runoff flows in the southwest direction toward the existing storm water basin depicted as waste treatment system 1. The storm water basin receives water from the adjacent golf course and residential development and does not have an outlet. The storm water management system is currently maintained and functioning to manage storm water runoff in this area. The applicant's proposal is to expand the existing basin in association with future development of the parcel, therefore the future use of the basin would continue to function for storm water management. .
