- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The site contains a 0.073-acre wetland (Wetland 3) in the northwestern portion of the project site. Wetland 3 is located in an area where a house and barn used to be located in the 1990's and is located in a depression at a higher elevational area of the site and is underlain with the Fincastle silt loam, which has a shallow perched water table. Wetland 3 contains a mixture of herbaceous and small saplings and is surrounded by the uplands and the roughs of the former golf course. The wetland is located in uplands, is surrounded by uplands and lacks a connection to the tributary system of the Little Miami River. Wetland 3 overflows along the southwestern boundary and flows over the lands surface and then dissipates or spreads out over the land before reaching the tributary system of the Little Miami River. There is no apparent stream or connection to the tributary system. Wetland 3 is not considered a water of the United States and is non-jurisdictional (Isolated) .**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
