The closest jurisdictional stream is approximately 500 feet away. This feature would not support interstate or foreign commerce interest, nor does they it contain any rare or threatened and endangered species. Wetlands C (0.07 acre) is completely surrounded by uplands, with no surface water connection to a water of the United States, and no nexus to interstate or foreign commerce. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

Wetland B and Wetland C are isolated waters completely surrounded by uplands, with no hydrologic connection to the tributary system. There is no indication of interstate or foreign commerce associated with the wetlands or features, and the wetlands or features do not provide suitable habitat for endangered species.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form contains all the isolated/non-jurisdictional waters where there is no obvious indication of overland flow from any of the identified wetlands. No obvious hydrologic connection to the tributary system was noted during a field inspection performed by the applicant's agent. There was no indication of commerce associated with the Wetland B and Wetland C. The property is privately owned. They are not predicted to be used as habitat for endangered species. There is no public access to the site.
