- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The site contains a 0.018-acre scrub/shrub-emergent wetland (Wetland A) in the northwestern portion of the project site. Wetland A is located in a depression, adjacent to a mowed trail and in an area of the site where a sewer easement exists and a manhole is located and ATV trails were observed. There is no apparent stream or connection to the tributary system. There was no indication that the wetland overflowed into surrounding areas. The wetland was determined to be isolated with no hydrologic connection to the tributary system and no substantial nexus to interstate or foreign commerce. The wetland is located in uplands, is surrounded by uplands and lacks a surface water connection to Stream 3 and Stream 4 and the tributary system of the Great Miami River. Wetland A is not considered a water of the United States and is non-jurisdictional (Isolated) .**

Pond 1, 0.366-acre, is located in the east-central part of the site and was constructed over 10 years ago by excavating in uplands and creating an earthen berm along the northern and western sides of the pond to capture runoff. The Pond does not have a discharge point and is not connected to any tributary system. A small ephemeral stream (Stream 13), located on the south side of the pond, drains north and into the pond. No evidence of an outlet or outlet channel was observed in the field. The pond is not considered a jurisdictional water of the United States.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The site contains a 0.018-acre scrub/shrub-emergent wetland (Wetland A) in the northwestern portion of the project site. Wetland A is located in a depression, adjacent to a mowed trail and in an area of the site where a sewer easement exists and a manhole is located and ATV trails were observed. There is no apparent stream or connection to the tributary system. There was no indication that the wetland overflowed into surrounding areas. The wetland was determined to be isolated with no hydrologic connection to the tributary system and no substantial nexus to interstate or foreign commerce. The wetland is located in uplands, is surrounded by uplands and lacks a surface water connection to Stream 3 and Stream 4 and the tributary system of the Great Miami River. Wetland A is not considered a water of the United States and is non-jurisdictional (Isolated) .

Pond 1 (0.366-acre) is located in the east-central part of the site and was constructed over 10 years ago by excavating in uplands and creating an earthen berm along the northern and western sides of the pond to capture runoff. The Pond does not have a discharge point and is not connected to any tributary system. A small ephemeral stream (Stream 13), located on the south side of the pond, drains north and into the pond. No evidence of an outlet or outlet channel was observed in the field. The pond is not considered a jurisdictional water of the United States .
